## **TEMPORARY STOP NOTICE**

- 1. The Council considers that there has been a breach of planning control on the land described in paragraph 3 below. The breach of planning control is an unauthorised engineering operation.**
- 2. This temporary stop notice is issued by the Council, in exercise of their power in section 171E of the 1990 Act, because they think that it is expedient that the activity specified in this notice should cease on the land described in paragraph 4 below. The Council now prohibits the carrying out of the activity specified in this notice. Important additional information is given in the Annex to this notice.**
- 3. THE REASONS FOR ISSUING THIS NOTICE**  
  
The engineering/quarrying operation gives rise to significant concerns relating to adverse drainage and land stability issues.
- 4. THE LAND TO WHICH THIS NOTICE RELATES**  
  
Land at Horton Quarry, shown hatched red on the attached plan.
- 5. ACTIVITY TO WHICH THIS NOTICE RELATES**  
  
The extraction and removal of material from the site.
- 6. WHAT YOU ARE REQUIRED TO DO**  
  
Cease all the activity specified in the Notice.
- 7. WHEN THIS NOTICE TAKES EFFECT**  
  
This notice takes effect on 07/03/2017 when all the activity specified in this notice must cease. This notice will cease to have effect on 4<sup>th</sup> April 2017

### **WARNING**

**THIS NOTICE TAKES EFFECT ON THE DATE SPECIFIED IN PARAGRAPH 7. THERE IS NO RIGHT OF APPEAL TO THE WELSH MINISTERS AGAINST THIS NOTICE.**

It is an offence to contravene a temporary stop notice after a site notice has been displayed or the temporary stop notice has been served on you (section 171E(4) of the 1990 Act). If you then fail to comply with the temporary stop notice you will be at risk of **prosecution** in the Magistrates' Court, for which the maximum penalty is £20,000 on summary conviction for a first offence and for any subsequent offence.

The fine on conviction on indictment is unlimited. If you are in any doubt about what this notice requires you to do, you should get in touch **immediately** with:
